**Subject: Southern California Edison (SCE) Construction Activities in Your Area:
Electrical Line Upgrade and Placement of New Structures**

Dear resident,

Southern California Edison (SCE) is currently upgrading its electrical line within the city of Chino Hills as part of SCE's **Tehachapi Renewable Transmission Project (TRTP)** that will deliver clean renewable energy to the region and strengthen SCE's electrical system. We apologize for any inconvenience this may cause and will make every effort to minimize potential impacts during construction. We appreciate your patience during construction of this important project. **The activities will not require a disruption of electrical service.**

Placement of Upgraded Electrical Transmission Structures and Wire

- New steel electrical transmission structures (*ranging approximately 185 to 198 feet in height*) will be placed along the utility right-of-way corridor in your area, as described below
- Electrical transmission wire (*220 kilovolt*) was recently removed and upgraded wire (*500 kilovolt*) will be installed in the project area

Construction Schedule

- Construction activities are in progress in Chino Hills and are expected to continue through approximately December 2011
- Construction hours will be 7:00 a.m. – 5:00 p.m., Monday – Friday
(*Note: Schedule may change due to weather, outages, environmental constraints and other factors.*)

Construction Area in Chino Hills (in existing utility right-of-way corridor)

- From the city's western border near Tonner Canyon, proceeding northeast (south of Eucalyptus Avenue) to Peyton Drive, and;
- Continuing east (between Alder Place and Garden Court) to the Chino Valley Freeway (71)

Traffic Safety Measures / Temporary Lane Closures

- Activities may require short periods of road and/or traffic lane closures adjacent to work being performed at the utility right-of-way
- SCE activities will comply with all local traffic regulations and will do everything possible to minimize any effects on traffic

Tips for Minimizing Construction Impacts

SCE is committed to minimizing any inconvenience and ensuring public safety during this work. In addition to SCE efforts to minimize the impacts to residents and businesses during construction, here are some simple tips that may help you reduce construction disturbance:

- Close all windows and doors facing the construction area in order to reduce noise and dust.
- Watch for information updates to ensure you have the most up-to-date information about construction activities taking place in your area.
