



## LOCAL APPOINTMENTS LIST

### MADDY ACT

The Maddy Act takes into consideration a vast and largely untapped reservoir of talent which exists among the citizenry that all too frequently is not aware of the opportunities for participation on local regulatory and advisory boards and commissions. For that reason, the Maddy Act was enacted for maximum public awareness of appointments to be made by the Governor, the City Council, or other legislative bodies (Government Code §54970).

In accordance with this provision, on or before December 31st of each year, the legislative body or City Council must cause to be prepared a list of appointments of all ongoing boards, commissions, and committees which are appointed by the City Council. This list shall include all appointive terms which will expire during the next calendar year with the name of the incumbent appointee, the date of appointment, the date the term expires, and the necessary qualifications for the position (Government Code §54972).

In accordance with Government Code Section 54972(a), the following is a list of all appointive terms that will expire during calendar year 2016:

#### Parks and Recreation Commission:

Special Qualifications: At all times during incumbency be a bona fide resident and registered voter of the City. No member of any board or commission shall be a City employee, nor shall any person be a member of more than one board or commission at any one time. In addition, there shall also be a non-voting Student Member who shall be a Chino Hills resident with either junior or senior class ranking, and good academic standing; and a non-voting ex-officio Member who must serve on the Board of Education of the Chino Valley Unified School District and be appointed by the Board of Education of the Chino Valley Unified School District. No officers or employees of the City or person under any employment contract subject to the jurisdiction of the City Council shall be a member of the Commission.


