**INFORMATION AND PROCEDURES: These terms are in reference to Chino Hills Municipal Code 10.16. Read and initial each item below to show that you understand and agree to with the terms of the permit:**

- \_\_\_\_\_ 1. Parking Permits will only be issued to residents that reside within the Restricted Parking Zone as identified and will be limited to the following streets: Reservoir Place, Tact Court, Honeysuckle Avenue, Ermine Drive, Sambar Street, Violet Street and Crest Court. **Parking permit is not valid for parking on Eucalyptus Avenue.**
- \_\_\_\_\_ 2. A two-year Temporary Parking Permit shall be valid for two years and expires on December 31<sup>st</sup> of the year on the permit.
- \_\_\_\_\_ 3. Parking Permits will not be issued to trailers or motorcycles.
- \_\_\_\_\_ 4. To be valid, Parking Permits must be permanently affixed to the inside of the driver-side windshield in the lower left corner of the vehicle which the permit was issued to.
- \_\_\_\_\_ 5. To the extent possible, vehicles must be parked adjacent to the address the permit was issued to.
- \_\_\_\_\_ 6. City parking regulations take precedence over "Restricted Parking Zone Parking Permits." Therefore, vehicles may not be parked on a City street during the hours and on the days that parking is prohibited on that street by ordinance or statute (i.e. street sweeping day). For street sweeping schedule or information, please call (909) 364-2800.
