1,2,3-Trichloropropane (1,2,3-TCP) Removal Treatment Plant project (CIP No. W19002)--The project includes purchase of 0.37 acres of land for and the installation of Granular Active Carbon (GAC) treatment vessels in a tandem series train for the removal of 1,2,3-TCP from the City's groundwater supply prior to sending the domestic water to distribution system. The GAC treatment system is designed to remove 1,2,3-TCP that is currently found in several City of Chino Hills wells at rates above the maximum containment level (MCL) set by the California State Water Resources Control Board adopted Resolution no. 2017-0042. The Project will also include a Zoning Map Amendment to change the zoning designation of the site from Private Institutional to Public Institutional. The project site is a 0.37-acre property within Assessor Parcel No. 1022-591-02, and is addressed at 90 Independent Court, Chino Hills, County of San Bernardino, within the Boys Republic property.
