CONTAINING 8,341 SQUARE FEET OR 0.191 ACRES, MORE OR LESS.

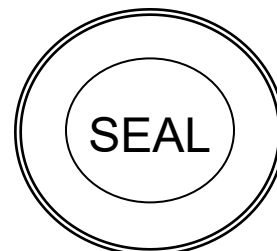
