TEMPORARY SALES PERMIT

Type of Sale: Garage/ Yard Sale

Validity of Permit: An individual or household shall be limited to three sales (permits) per twelve-month period and each sale shall be limited to three consecutive days OR two consecutive weekends of two days each. Each sale shall be at least 60-days after the last day of the preceding sale. Such sales may be conducted only between the hours of 8:00 a.m. and 6:00 p.m.

CONDITIONS OF PERMIT

CHMC 5.04.330(A) Permit Required: It is unlawful for any person, firm, or corporation to conduct or carry on any sales activity commonly described as a yard, garage, patio, rummage, or similar type sale within the city without first having obtained a permit.

CHMC 5.04.330(E) Only Applicant's Own Personal Property to be Sold: Before a permit may be issued, a sworn statement must be filed with the Collector stating that all property to be sold is the applicants own personal property and has not been acquired or consigned to him/ her for the purpose of resale. If occupant of premises is selling another's property, said property owner must also obtain a permit and sign a sworn statement stating that it is his/ her own personal property.

CHMC 5.04.330(F) Display of Goods: Sale goods may not be displayed in the public right-of-way, and all goods shall be arranged so that fire safety services and other officials may have access for inspection at all times during the sale. Sale goods may only be displayed on the day of, and between the hours of sales as provided in this ordinance.

CHMC 5.04.330(G) Signs: No other signs shall be permitted, except one double-faced sign, not to exceed six square feet in area and the maximum height shall be five feet. Such sign shall have a maximum height of four feet when placed within the front yard or side street yard setback. The sign shall be permitted only on the property where such sale is located. Such sign may be posted 24-hours prior to the sale and must be removed immediately following the sale.

***No signs shall be placed on city property. Signs in violation are billed at \$45.00 a sign.**

CHMC 5.04.330(I) Violation Penalty: Any person violating any of the provisions of this section shall be guilty of an infraction and upon a first conviction thereof shall be punished by a fine.

I hereby certify that I have reviewed the above regulations, that all property to be sold is the applicant's own used property and that no new items that have been acquired or consigned for the purpose of resale. Only one family per permit is allowed.
